Security patrol in North Buckhead?

Many Buckhead neighborhoods have paid off-duty police officers or security guards on duty part-time to provide a sense of additional security to their residents. In some cases, the patrols are paid for as a part of the neighborhood associations' annual dues. In other cases, the patrol is paid for by individuals who subscribe. To provide some suggestion of the cost of a security patrol, "Historic" Brookhaven, the neighborhood immediately to our east, charges civic association membership dues of \$285 a year, which includes membership in their security patrol. Our association charges \$35 a year for residential memberships. Much of this \$250 per year difference is due to the cost of the security patrol. Obviously, a "critical mass" of security patrol subscribers is needed to make economic sense. In addition, North Buckhead is huge and is varied in character, so a patrol might make sense in only some areas. Further, some condominiums already have a security patrol and don't need another one. NBCA needs your help in deciding whether our neighborhood should pursue a security patrol. Would you like NBCA to pursue a security patrol in your part of North Buckhead?

Answer

- I expect police patrols for the tax dollars I pay. I don't support paying twice for protection.
- Our neighborhood has security measures.
- perhaps, if there are enough residents to lower the cost a bit from \$250 yr
- Our subdivision has its own security; perhaps having an NBCA patrol in other areas that are not covered could make some sense. Obviously, the cost and its distribution among members should be carefully considered.
- It may be necessary in the future if crime rates increase.
- Our neighbors watch after each other to some extent but we would contribute to a security service if the majority wanted one.
- We just moved into the area in October and I have seen Security Patrols present in neighborhoods over towards NAHS. My feeling at this time is that it would be worth pursuing, however, I am open to listening to those who may disagree with me.
- The financing obstacles seem unsolvable
- Agree however that we need a majority of participation. This is like a "public good" where few of us pay and all of us benefit... that is unfair.
- I am interested in this, but question how effective it would be given the size of our neighborhood. I think it is worth researching, however.
- I am against hiring off-duty officers or professional security patrol personnel. I believe a more cost-effective solution would be to start a neighborhood watch (with signage posted to this effect). This way, there is no overlap with condo/apartment security already in place and the most offended areas can have a higher rate of attentiveness - by neighbors who are at home and have an investment in keeping their street safe.
- I would be interesting in gather more information about it.
- I think it is worth investigating, but not the highest priority.
- If it will be a significant one that is able to be effective. If there are not enough patrol cars/etc it is an exercise in futility and will make residents unwilling to pay up!
- 4620 Wieuca has a security patrol company owned by Barry Miller. He has been very helpful. This is a good service for neighborhoods.

- But need to understand how this would complement the city/county services.
 - I believe a neighborhood watch program would be sufficient.
 - NO, this is double paying for a service and paying for *protection*. Considering the amount of taxes paid by us we would not pay for Tony Soprano type of protection by APD who is suppose to be protecting the city.
Is you are robbed who is liable then? What would be the accountability?
 - If the government of the City of Atlanta can not provide the basic service of protection of its citizens then the NBCA should start a campaign to ask for resignations Howard Shook would be a good start.
 - We should NOT have to do this with the amount of taxes we pay. I would like to see a comparison of police force for the South side of Atlanta vs. Buckhead AND THEN compare the differences in taxes paid..... This is just a disgrace. Buckhead should stand up for what is due to us...what we pay for! I don't feel comfortable letting my son play in our yard without being right there. That is just terrible. We have had a car stolen, one broken into, and other things stolen...NOT accep
 - No crime, nobody can find us:-)
 - Regardless of the end result, the idea is worth exploring.
 - our sky-high property taxes should cover APD to do their job.
 - I think that we should continue to build relations with the City of Atlanta PD. I have been complaining about the noise at 6:50-7:20 am at Piedmont Center (construction, leaf blowing) for over a year. I cannot get any support from this association or Shook's office. The PD changes shifts during this time and is understaffed. Security patrol won't help this issue - simply enforcing the ordinance would solve the problem.

Speed Radar Signs

As reported in the front page article in the March newsletter (www.nbca.org/newsletters/2010-03), NBCA has purchased a speed radar sign with the assistance of a grant from the Buckhead Coalition. These signs perform two services: - They provide immediate feedback to an approaching driver, alerting them that their speed may be excessive. - The units can capture traffic speed history, which can be turned over to the Atlanta Police Department so they can target problem areas. Any data provided includes only location, date/time, and speed and does not include any information about individual drivers and vehicles. These signs are portable so they can be moved from one location to another in the neighborhood and are equipped with burglar alarms to deter theft.
